- **A. Zoning District Map Update Discussion:** ZA Preston asked the Commissioners if they wanted to look into the parcels that are split zoned, update the map, and then have new maps printed. Discussion took place with the consensus of not to update the zoning on the split parcels but to get one map with the current land divisions shown on it printed.
- B. Group Day Care Home Proposal Discussion: ZA Preston asked for an informal discussion to assess the Commissioners willingness to consider this topic before a

- formal application was made. Discussion took place with the consensus that the applicant should first talk with their neighbors before making the formal application.
- C. Private Road Application Review: ZA Preston talked about where this private road would be going, that the engineered drawings are being reviewed by the Township Engineer, that the Township Attorneys are reviewing the documents, that she has sent the information to all other agencies that need to review the documents. Preston stated that she was looking for the Commissioners to take the action of approving/granting a preliminary permit by the zoning administrator. Discussion took place. *Motion by* Jordan, supported by Swartz, to approve/grant a preliminary permit by the Zoning Administrator to be issued for the private road. All ayes, no nays, motion passed.
